#### Definitions of Mandatory Fees 2025-2026

Carlow University mandatory fees are non-waivable costs charged to all students for a specific academic semester of enrollment, covering services and resources like technology, student activities, and health facilities. These fees are in addition to tuition and room and board. The total cost of attendance includes tuition, fees, housing, books, and other living expenses, with mandatory fees varying by undergraduate or undergraduate standing. Fees are displayed on the student invoice available via Self Service.

**University Fee (TRAD - \$532 year/\$266.00 Fall & Spring) (Adult/Master/Doc - \$20 per credit fall, spring and summer) NOTE: TRADS are charged \$20 per credit over the summer**

The University Fee provides funding for administrative services, academic support, police, and safety initiatives.

**Student Activity Fee (TRAD -\$296 year/\$148.00 Fall & Spring) (Adult/Master/Doc – N/A)**

The Student Activity Fee provides direct financial support to student organizations, as managed by the Student Government Association.

**Graduate Student Activity Fee (TRAD – N/A) (Master/Doc -\$104 year/\$52 Fall and Spring)**

The purpose of this fee is to enhance the graduate student learning experience. Specifically, all fees provide funding to the Graduate Student Government Association to fund graduate student activities, networking opportunities, individual and student group conference attendance, individual and group research, and/or other such opportunities student leaders deem to be appropriate.

**Technology Fee (TRAD/Adult/Master/Doc - \$268 year/\$134 Fall and Spring)**

The Technology Fee provides funding for quality technology resources and services such as the Help Desk, hardware and software support, technology-enabled classrooms, printing capabilities, and wireless access. Fee covers costs associated with administration and support of instructional technology including the college's Learning Management System.

**Health and Wellness Fee (TRAD/Adult/Master/Doc - \$134 year/\$67 Fall and Spring)**

The Health and Wellness Fee provides direct support to Health Services, Counseling Services, Wellness and Fitness, and the overall enhancement of student health and wellness.

**Transportation Fee (TRAD/Adult/Master/Doc - \$142 year/\$71 Fall and Spring) NOTE: Students with online location – not charged this fee**

The Transportation Fee provides funding for the U-Pass via Pittsburgh Regional Transit, as well as the cost of campus transportation operations including maintaining parking lots and roadways, enforcement, and administration.

**Graduate CHW Fee (Master/Doc - \$150 per semester Fall/Spring/Summer)**

This fee supports overhead costs associated with administrative release time for clinical placement directors and site coordinators, additional adjunct faculty requirements to support the low student to faculty ratio required for clinical supervision.
